The email included a very brief summary of the meeting between Qaasimul Uloom and the MJC and a request for Mufti Abdul Kader to avail himself for a sitting with the MJC to address the issues of concern.

Mufti Abdul Kader responded via a number of voice messages to our Mudeer Moulana Anwar Peters.

Mufti Abdul Kader agrees to meet with the MJC but on condition and subject to the;

1. MJC first apologising publicly on air for closing the Masaajid even before the Government required

2. MJC apologising publicly on air for acting as "Friends of the Court" in the Court Application relating to the opposition of closing the Masaajid,

3. MJC to apologise publicly on air for joining with Women's League in the Court Application regarding the Muslim Personal Law Bill.

4. MJC to clarify their stance on the Shiah whether they are kuffaar or not.

Only when the MJC are willing to do the above and declare the Shiah to be kuffaar is Mufti Abdul Kader prepared to meet with them.

We wish to re-emphasize our roll as facilitator in this matter only and undertake to continue our endeavour to facilitate an amicable resolution between the MJC and Mufti Abdul Kader and to establish a line of meaningful communication between the two parties.

OUR COMMENT

As long as the MJC plods its current path of **kufir**, there is no possibility for reconciliation.
